# Chair's Report - 2011/12

It is with pleasure that I present to you the 2011/12 (2<sup>nd</sup>) Annual Report of the ARONAH.

The work of the board and subcommittees for the financial year 2011/12 has largely focussed on achieving key goals articulated in our strategic plan.

#### These have included

- Development of terms of reference for educational and practice standards, accreditation guidelines and policies for naturopathy and herbal medicine.
- Ratification and adoption of the ARONAH constitution achieved at the 1<sup>st</sup> AGM held in Brisbane on the 9<sup>th</sup> of November 2011.
- Ratification and adoption of the ARONAH By Laws.
- The subcommittees to develop standards, codes, guidelines and requirements for naturopaths and herbalists to underpin national, uniform standards of education and practice for the professions of naturopathy and western herbal medicine – which is an ongoing project.

ARONAH continues to receive frequent correspondence from practitioners both domestic and international, registered and unregistered, wanting to register with ARONAH or be added to our mailing list, from students asking for advice regarding their current or future potential course of study, from the public wanting recommendation or referral to well qualified practitioners.

ARONAH received complaints 3 from the public regarding practitioners which were referred to their professional associations, state health care complaints commissions or police as appropriate.

ARONAH was present at the Southern Cross University Professional Day in 2011.

Our board and administrator have also been busy liaising with government and industry representatives on a number of issues surrounding the professions of naturopathy and Western herbal medicine. Formal meetings were held with Janelle Saffin MP (Federal Member for Page) on 15 November



2011, The Hon Thomas George (State Member for Lismore) on 29 November 2011. ARONAH also sent a copy of the published Lin Report to the Australian Health Minister's Advisory Council.

This year, the ARONAH board has upgraded to a professional teleconferencing facility.

ARONAH also sent a letter to every Federal, State and Territory Health Minister requesting that

- the report The Practice and Regulatory Requirements of Naturopathy and Western Herbal Medicine (2005) be brought to the Australian Health Minister's Advisory Council for consideration
- A copy of the report regarding the regulatory options for unregistered health professionals also be considered by the AHMAC as a matter of urgent priority.
- a meeting be held with each health minister regarding the matter of registration of naturopaths and western herbalists.

A call for nominations for the election of 3 practitioner board positions in NSW, QLD and VIC and 3 community members was made in June of 2012. The board would like to thank our outgoing members Ms Nirala Jacobi (QLD), Ms Liza Oates(VIC), Dr Airdre Grant, Ms Michelle Rosenthal and Ms Kate Johnstone for their assistance with the board. We would have achieved nothing without their input.

I would like to thank the board, the subcommittee members and our administrator for their generous provision of the many hours of voluntary work required to keep ARONAH progressing. Again without them ARONAH ceases to function.

We are also grateful to the generous donors who have provided seed funding and infrastructure support to ARONAH as without their support, we would not exist. ARONAH received \$8617.92 from the Federation of Natural and Traditional Therapists (FNTT) as per the FNTT constitution on the winding up of their organisation.

Due to the extended amount of time required for the establishment of the register, the board has revised the commencement date but looks forward to a fully operational register in mid 2013.
