CRIMINAL HISTORY

Criminal history includes the following, whether in Australia or overseas at any time:

- every conviction of a person for an offence
- every plea of guilty or finding of guilt by a court of the person for an offence, whether or not a conviction is recorded for the offence,
 and
- every charge made against the person for an offence.

Under the National Law, spent convictions legislation does not apply to criminal history disclosure requirements. Therefore, you must disclose your complete criminal history as detailed above, irrespective of the time that has lapsed since the charge was laid or the finding of guilt was made. The Board will decide whether a health practitioner's criminal history is relevant to the practice of the profession. PROFESSIONAL INDEMNITY INSURANCE (PII)

You must not practise unless you have PII arrangements in place for your full scope of practice that comply with the Board's registration standard. You can be covered by either individual insurance arrangements or group schemes for PII arrangements. Group schemes include cover via your employer's insurance arrangement or cover through membership with a professional association. PII must include a minimum of \$5 million in cover for any single claim, a minimum of one automatic reinstatement during each year of cover, run-off cover and product liability if you use, sell or dispense therapeutic goods. If you are unable to meet the Board requirements you are ineligible for registration. For more information, view the full registration standard online at
